

**AN ORDINANCE AUTHORIZING AND APPROVING AN AGREEMENT BETWEEN LOWER CHANCEFORD TOWNSHIP AND SOUTHERN YORK COUNTY EMERGENCY MEDICAL SERVICES, A PENNSYLVANIA NON-PROFIT CORPORATION, (HEREINAFTER REFERRED TO AS "SOUTHERN YORK COUNTY EMS"), FOR THE PROVISION OF AMBULANCE SERVICE IN LOWER CHANCEFORD TOWNSHIP**

**WHEREAS**, 53 P.S. §66528 authorizes a second class township to appropriate monies toward ambulance and rescue and life-saving services and to make contracts relating thereto; and

**WHEREAS**, it has been determined by the Board of Supervisors of Lower Chanceford Township that it can best provide ambulance service for its residents by entering into a contract with Southern York County EMS to provide ambulance and rescue and life-savings services for its residents.

**NOW, THEREFORE**, be it ordained and enacted by the Board of Supervisors of Lower Chanceford Township, York County, Pennsylvania as follows:

**SECTION I.** Lower Chanceford Township shall execute and enter into an Emergency Medical and Ambulance Services Agreement with Southern York County EMS for the provision of emergency medical and ambulance services within Lower Chanceford Township.

**SECTION II.** Copies in the form presented to Lower Chanceford Township at this meeting and so approved shall be filed with the Secretary of Lower Chanceford Township, and shall be filed with the minutes of the meeting at which such ordinance was adopted and shall be made available for inspection at reasonable times by interested persons requesting such inspection.

**SECTION III.** The Chairman and Secretary of Lower Chanceford Township are authorized and directed to execute and deliver the Agreement on behalf of the Township substantially in the form approved in Section I hereof with such changes as may be approved by the Board of Supervisors with the execution of this Agreement by the Chairman and Secretary of Lower Chanceford Township to constitute conclusive evidence of its approval.

**SECTION IV.** It is declared that the enactment of this Ordinance is necessary for the protection, benefit and preservation of the health, safety and welfare of the inhabitants of Lower Chanceford Township.

**SECTION V.** This Ordinance shall be known as the "Lower Chanceford Township Emergency Medical and Ambulance Services Ordinance."


