

AN ORDINANCE TO AMEND THE "LOWER CHANCEFORD TOWNSHIP HOLDING TANK ORDINANCE" AS ENACTED ON DECEMBER 11, 1991.

BE IT ENACTED AND ORDAINED by the Board of Supervisors of Lower Chanceford Township, York County, Pennsylvania as follows:

Section 4 of the Lower Chanceford Township Holding Tank Ordinance is hereby amended to add at the end thereof the following:

The agreement executed by the individual, firm, or corporation responsible for the removal of the contents of the holding tank shall also obligate such individual, firm, or corporation to forward to the township Sewage Enforcement Officer a copy of the York County Solid Waste and Refuse Authority Septage Manifest (hereinafter "Manifest") within three (3) days following each time such individual, firm, or corporation removes contents from the holding tank. Such individual, firm or corporation shall at the time of forwarding the Manifest to the township Sewage Enforcement Officer inform the township Sewage Enforcement Officer whether any violations of any of the provisions of this ordinance regarding the holding tank were observed during the removal process.

In the event the individual, firm or corporation obligated to remove the holding tank contents intends to terminate the agreement because of nonpayment by the permit holder or for other reasons, such individual, firm or corporation shall inform the township Sewage Enforcement Officer in writing by certified mail of such intention and all obligations of such individual, firm or corporation shall cease thirty (30) days following receipt by the township Sewage Enforcement Officer of such notification. Following receipt of such notification, the township Sewage Enforcement Officer shall notify the permit holder by certified mail that unless a new agreement is entered into with another individual, firm or corporation to assume responsibility for removal of the contents of the holding tank in accordance with the provisions of this section of this ordinance and presented to the township Sewage Enforcement Officer within such thirty (30) day period, the permit for such holding tank shall be revoked. If such agreement is not presented to the township Sewage Enforcement Officer within such thirty (30) days period, the township Sewage Enforcement Officer shall revoke the

permit upon the expiration of such thirty (30) day period. The permit holder must cause the holding tank to be removed from the property within ten (10) days from the date of revocation of the permit.

AN ORDINANCE TO AMEND THE LOWER CHANCEFORD TOWNSHIP
HOLDING TANK ORDINANCE

IT IS HEREBY ENACTED AND ORDAINED by the Board of Supervisors of Lower
Chanceford Township, York County, Pennsylvania, as follows:

SECTION 1. Section 6 of the of the Lower Chanceford Township Holding Tank Ordinance is hereby amended to delete the word "Resources" wherever set forth and substitute the word "Protection".

SECTION 2. Section 8 of the Lower Chanceford Township Holding Tank Ordinance is hereby amended to delete the following: "One Hundred Twenty-Five (\$125.00) Dollars" and to substitute therefore the following: "Six Hundred Twenty-Five (\$625.00) Dollars".

SECTION 3. Section 9 of the Lower Chanceford Township Holding Tank Ordinance is hereby amended to delete the following: "Five Hundred (\$500.00) Dollars" and to substitute therefore the following: "One Thousand (\$1,000.00) Dollars".

SECTION 4. Section 10 of the Lower Chanceford Township Holding Tank Ordinance is hereby amended to delete wherever it appears the following: "Fifty (\$50.00) Dollars" and to substitute therefore the following: "One Hundred (\$100.00) Dollars".

SECTION 5. Section 17 of the Lower Chanceford Township Holding Tank Ordinance is hereby amended to delete the same in its entirety and to substitute therefore the following:

"All "retention" tanks shall be built of concrete or of other acceptable material approved by the Department of Environmental Protection and have hold downs to prevent flotation as required by the township's Sewage Enforcement Officer. Retention tanks shall be water tight and must be installed in a manner which insures that they will not float when empty due to hydraulic action of ground water and/or storm water runoff."
